FOR CREATIVE THESIS PROJECTS WRITTEN COMPONENT AND THESIS DEFENSE

If you are a Director, Actor, Manager, Designer, or Dramaturg, the graduation thesis is a "capstone experience," designed to provide you with a holistic, cumulative experience that encompasses all of your graduate education. For Theater Arts, the creative thesis requires not merely artistic event itself but a stage of elevated critical engagement with the creative work. This process requires reflection on the process, an analysis which links the creative work into larger discourses about art and culture, and a discussion of one's work at a professional level, with other professionals.

This document is meant as a guide for you to follow as you enter this final stage of your graduate education. It is a guide, not a straitjacket. You will have the opportunity, and the responsibility, of making it yours.

- Stage 1: Reflection (Abstract)
 - During FALL QUARTER, you will arrange a meeting with your advisor before OCTOBER 11 to discuss the requirements of your Capstone Thesis, complete your paperwork, and finalize your internship credit for the 5unit THEA 293 course.
 - Near the END of FALL QUARTER, you will meet with your advisor to discuss your advancing thesis plans.
 - You will arrange a meeting with your advisor to take during week 1 or 2 of WINTER QUARTER to turn in to your advisor a *Reflection Document* which looks like this:
 - It is at least 750 words long
 - It details your motivations for choosing the project.
 - It details the notions you had going into the project and how are changing
 - It details what you hope to learn from the process.

- At the meeting with your advisor, you will discuss the paper and the next step of the process. You will then be given direction by your faculty advisor towards placing your work in this project into a larger conversation about theater, which leads you to Stage 2
- By the end of Winter Quarter, you must have assembled your Thesis Committee, which is composed of your advisor as the Chair of the Committee, and at least two other professors, one of which may be from another UCSC department. It is your responsibility to seek out and request that these professors sit on your committee.
- Stage 2: Larger Discourses (Prospectus)
 - Your second paper builds on your first to create an analysis of your own work within the context of larger discourses on theater theory and practice. This paper should have the following traits:
 - It should be at least 2,000 words (including the stage one abstract you already finished)
 - Articulate links between your work at UCSC and work going on in the larger theater world
 - Think about what you have read, discussed, or written about for your classes, grad and undergrad, and your individual outside research, that have guided or sparked your creativity. For example, if you are writing about your preparation for a role in a particular play, what training techniques were parts of your process?
 - Explore your ideas beyond what you write. During your thesis presentation, you will be asked to defend the statements you make, and even to move beyond them.
 - You will finish this assignment in advance of the beginning of SPRING QUARTER, and get it to your advisor in advance of classes starting.
 - o In week 1 or 2 of Spring Quarter, you will meet with your advisor to discuss this paper.
 - This second meeting, you will discuss this paper with your advisor, who
 will give you detailed criticism so that you can complete the final stage of
 the process, which is writing the thesis and preparing the presentation
 for the Defense.
 - $\circ\quad$ You will arrange to meet with your advisor once per week during Spring Quarter prior to May 1.

A NOTE. It is up to you to schedule the appointments with your professor, to complete the assignments within a reasonable amount of time, and to follow through on them. Failure to follow through with these responsibilities might seriously jeopardize your ability to graduate.

• Stage 3: Thesis

- The Thesis is the third document you will write, which is based on and includes the work you've already done, with all the revisions necessary.
- It is a substantial, rigorously researched, carefully organized, and clearly articulated analysis of your work within the larger context of discourses within your discipline.
- The exact length of the paper is to be determined between you and your advisor, but it may not be shorter than 2,500 words.
- These must be completed and distributed to all members of your committee members no later than one week in advance of your scheduled presentation date.
- NOTE: Dramaturgs must include a complete Production Casebook in addition to the Thesis.

Stage 4: Defense

- The Defenses will take place during the second and third weeks of May (unless you have a Spring Thesis, see your advisor).
- The Defense Session
 - It will be your responsibility to arrange the date, time, and room with Angela Beck in the main office, to make sure all of your committee members can make the time, and to remind your committee of the upcoming defense.
 - The Chair of your committee is responsible for convening and moderating the session.
 - The defense session will be one hour long.
 - During the first 5-10 minutes of the session, you will make an oral summary of your research.
 - You should consider this a formal, professional-level presentation. Dress and prepare accordingly.
 - You will be assessed on the following characteristics:
 - Depth and breadth of research
 - Rigor of theory and insight
 - o Organization of presentation
 - Clarity
 - Following the presentation, the assessing faculty will spend 20-30 minutes engaging you in a vigorous defense of your work.
 - Following the defense, you will be asked to leave the room, and the faculty will discuss your work for the next 15 minutes or so.
 - After the faculty has completed its discussion, you will be invited back into the room and given a summary of the faculty's recommendations for you. There are three possible results:
 - PASS. You have passed your thesis and are cleared to graduate.

- PASS WITH REVISION. You will be required to make some revisions to your thesis before you are cleared to graduate.
 - You must discuss the details of this with your advisor. Revisions are not accepted after the last day of Spring Quarter.
- FAIL. You will not be allowed to complete your work on your degree.
- Any further questions you have about the thesis should be addresses to your advisor. YOUR ADVISOR MAY ALTER ANY OF THESE REQUIREMENTS ACCORDING TO YOUR NEEDS AS A STUDENT.

SCHOLARLY THESIS

The capstone experience for the scholarly MA student is a work of serious, rigorous scholarship in the fields of theater history, theory, or performance studies. As with the Creative Thesis, the Scholarly Thesis proceeds in stages.

STAGE 1: ABSTRACT

By the third week of the first quarter, the student will have met with his or her advisor to complete all paperwork, resolve the requirements for the Internship course (THEA 293, 5 units), and to discuss the parameters of the thesis. Each student's project will have a different shape, but the general guideline for the thesis is a fully researched argumentative investigation of a single subject that is at least 7,500 words (25 standard pages).

By the end of the first quarter, the student will provide the advisor with an Abstract of no fewer than 500 words which contains:

- A detailed description of the goals of the thesis
- A survey of the evidence that will be examined
- An approach of the theories that will be applied
- A beginning of a reading list for further research

The student will meet with the advisor to go over this Abstract, discuss its merits and weaknesses, give guidance, and provide direction for further research.

STAGE 2: PROSPECTUS

By the LAST WEEK of Winter Quarter, the student will submit to the advisor a PROSPECTUS. This document is at least 1,500 words long and contains elaborations of all of the points listed in the Abstract, and in addition must include a detailed outline of the final Thesis, including section headings which explain where each element of the argument will appear in the overall structure of the paper.

 By the end of Winter Quarter, the student must have assembled the Thesis Committee, which is composed of the advisor as the Chair of the Committee, and at least two other professors, one of which may be from another UCSC department. It is the student's responsibility to seek out and request that these professors sit on the committee.

During the first or second week of Spring Quarter, the student will arrange a meeting with the advisor to review this document and get guidance for writing the final Thesis.

STAGE 3: THESIS

The Thesis, of 7,500 words in length at minimum, will be submitted to the advisor and each member of the committee no later than one week prior to the thesis defense.

STAGE 4: DEFENSE

The Scholarly Defenses will take place during the second and third weeks of May.

- o The Defense Session
 - It will be your responsibility to arrange the date, time, and room with Angela Beck in the main office, to make sure all of your committee members can make the time, and to remind your committee of the upcoming defense.
 - The Chair of your committee is responsible for convening and moderating the session.
 - The defense session will be one hour long.
 - During the first 5-10 minutes of the session, you will make an oral summary of your research.
 - You should consider this a formal, professional-level presentation. Dress and prepare accordingly.
 - You will be assessed on the following characteristics:
 - Depth and breadth of research
 - o Rigor of theory and insight
 - Organization of presentation
 - Clarity
 - Following the presentation, the assessing faculty will spend 20-30 minutes engaging you in a vigorous defense of your work.
 - Following the defense, you will be asked to leave the room, and the faculty will discuss your work for the next 15 minutes or so.

- After the faculty has completed its discussion, you will be invited back into the room and given a summary of the faculty's recommendations for you. There are three possible results:
 - PASS. You have passed your thesis and are cleared to graduate.
 - PASS WITH REVISION. You will be required to make some revisions to your thesis before you are cleared to graduate.
 - You must discuss the details of this with your advisor. Revisions are not accepted after the last day of Spring Quarter.
 - FAIL. You will not be allowed to complete your work on your degree.
